

# **The NSPCA Ward Combs Scholarship**

### **Guidelines for 2020 Scholarship:**

- 1. The student applying for the scholarship must be at least one of the following:
- A. Direct relative of an owner or an employee of a pest control business, and a member in good standing of the Nebraska State Pest Control Association. To be inclusive of son, daughter, son-in-law, daughter-in-law, grandchild, wife or husband of the owner or the owner (him or herself).
- B. It shall not include the following: brothers, sisters, uncles, aunts, nieces or nephews, unless they are employed in the business.
- 2. The student applying for the scholarship must meet the following criteria:
- A. The applicant must be a graduating senior, current college student, or have passed a high school equivalency examination indicating the completion of high school.
  - B. The applicant must be a resident of Nebraska.
- 3. The scholarship check will be made payable to the institution chosen by the recipient.
- 4. The applicant must be attending one of the following institutions:
- A. An accredited University, State College, Community College, Vocational, Business/Liberal Arts school.
  - B. Mini-workshops or courses will not qualify for the scholarship.

# <u>AWAR</u>D:

A minimum of two individual scholarships will be awarded in the amount of \$1,000.00 each.

Applications must be received by April 15, 2020 at 11:59pm ET.
